UPDATED EMERGENCY RULE LTC/ALF TESTING REQUIREMENTS

COVID ISOLATION SITES CONTINUE TO EXPAND. There are now 23 sites open in the state. Those facilities can be found here.

State supported testing sites will now prioritize testing for symptomatic individuals, individuals 65 and older, and those under 18 starting today, August 5.



Statewide Conference Call Summary

- Four East coast counties opened Special Needs Shelters in response to Hurricane Isaias. The shelter was low in attendance.


The shelter was broken into two sections: congregate and non-congregate. Patients were screened as they entered and those not meeting the criteria were placed in the non-congregate areas.

Masks and hand sanitizer were distributed with touch free options placed throughout the shelter as well.

Social distancing and spacing were enforced.

- Testing capabilities should continue to be expanded. especially in pediatric capabilities as counties prepare for the coming school year.
- We are 1 month away from flu vaccination season. Communities should stress the importance of receiving a flu vaccine in the midst of COVID-19.
- For those adults and children who have fallen behind on getting their vaccines. it is important to get caught up. This is especially true for those children returning to face-to-face schooling. Contact your local health department for information on how to receive these vaccinations.

- Continue working on messaging related to symptom based strategies to clear previous COVID positive individuals as this is being seen as successful.

ESS INFORMATION FOR REPORTING FACILITIES

- ESS is critically important for the State to anticipate demand in the hospital & sub-acute care setting. This data influences decisions on the need for additional support and equipment requests from federal government.
- Facilities MUST verify and update data once daily.
- ESS is adding more fields daily. Instructions on these new fields available on the AHCA ESS website.
- Hospitals should estimate the number of med surge beds that can be converted to ICU beds. Do not duplicate bed numbers in different categories. Start with highest acuity beds.
- Corporate Representatives can be established to monitor data entry at individual facilities. Contact AHCA for assistance
