


## ESS INFORMATION FOR REPORTING FACILITIES

- ESS is critically important for the State to anticipate demand in the hospital & sub-acute care setting. This data influences decisions on the need for additional support and equipment requests from federal government.
- Facilities MUST verify and update data 2x daily.
- ESS is adding more fields daily. Instructions on these new fields available on the AHCA ESS website.
- Hospitals should estimate the number of med surge beds that can be converted to ICU beds. Do not duplicate bed numbers in different categories. Start with highest acuity beds.
- Corporate Representatives can be established to monitor data entry at individual facilities. Contact AHCA for assistance.



## Statewide Conference Call Summaries

- Florida has tested roughly 110,000 individuals and currently has a 10.5% positivity rate. The mortality rate currently is 1.7%. 30% of those deaths occurred in ages over 85, with another 30% between the ages of 75 and 85. The current hospitalization rate is 12%, of which 1/3 of those are in the ICU. 1/3 of the ICU patients are on ventilators.
- Models are showing that the peak of the virus in Florida is about 2 to 3 weeks away, or around April 21st.
- Surgeon General Rivkees has stated it is of the utmost importance for hospitals to have a surge plan in place at this time. It is expected that each hospital will have the capability to surge to an additional 20% if needed.
- No elective surgeries should be taking place at this time to conserve PPE and other resources, as stated from the guidance of the Governor and Surgeon General. If a facility is continuing to perform these surgeries, they should be reported to AHCA immediately.
- Retired medical personnel, or those with expired licenses, wishing to assist in the COVID-19 response can now contact MQA to reinstate their license. This process is being fast-tracked at this time.
- AHCA has found there have been discrepancies when cross-referencing fields between the ESS data and the statewide data. It is imperative that facilities are meeting with entry staff to ensure the accuracy of the information being submitted.
- AHCA is asking all ambulatory surgery centers to begin looking at the possibility to convert Anesthesia Machines to Ventilators and report their findings.
- Currently, 40% of the total beds in the state of Florida are available along with a total of 6,000 ICU beds.
- Community Mitigation Measures are continuing to be one of the more effectives ways to help flatten the curve.
- Field hospitals have been set up in Miami-Dade and Broward County, and other locations are being looked at throughout the state.
